



The EU Council adopted a [decision](#) authorising eleven Member States - including the 4 biggest Eurozone economies Germany, France, Italy and Spain to go ahead with enhanced cooperation on a common system of financial transaction tax. A subsequent Commission proposal for a Council Directive implementing the enhanced cooperation in the area of financial transaction tax should follow in due course.
